Evaluating, Funding, and Disseminating Critical Research: Funding of high impact MG research at prominent universities and medical institutions, including leveraging funds in collaboration with strategic partners, such as the American Brain Foundation and MGNet, to bring new scientists to MG research through fellowships, funding pilot grants and special projects. MGFA maintains the only global MG patient registry, which has grown to include nearly 3,500 participants. MGFA sponsors an annual scientific session in conjunction with AANEM, attracting over 250 attendees. MGFA sponsors an International Conference every 3 years which attracts leading MG researchers from all over the world, attracting over 350 attendees. MGFA provides information to 40,000 plus constituents about research initiatives and

The MGFA conducts an annual awareness campaign, June MG Awareness Month, reaching out through our support groups, an awareness toolkit for all who are interested in raising awareness of MG in their communities, press releases, posters and promotion in social media.

Information, Education and Support: MGFA provides material, information and referral, and education and support programs to help people manage the challenges of living with myasthenia gravis. The MGFA website is one of the organization's greatest resources and is a premier source of information.
