Evaluating, Funding, and Disseminating Critical Research: MGFA supports high-impact myasthenia gravis research at leading universities and medical institutions, often collaborating with strategic partners such as the American Brain Foundation and MGNet. Through these partnerships, it helps attract new researchers to the field by funding fellowships, pilot grants, and specialized research projects. The organization also maintains the only global MG patient registry, which has grown to nearly 3,500 participants, providing valuable data to advance research. MGFA hosts an annual scientific session in partnership with AANEM, drawing more than 250 attendees, and organizes an International Conference every three years that brings together leading MG researchers worldwide, with attendance reaching around 660

Awareness and Advocacy: MGFA offers a wide range of free educational brochures, available in multiple languages, covering topics important to individuals living with myasthenia gravis, and makes them accessible to both patients and the general public. It also provides a professional manual and other key educational resources tailored for healthcare providers. In addition, MGFA leads an annual awareness campaign each June for MG Awareness Month, engaging its network of support groups and equipping individuals with toolkits, press materials, posters, and social media resources to help raise awareness of myasthenia gravis within their communities. MGFA also hosted a Patient Advocacy Organization Summit that brought together 44 representatives from 17 countries,
